



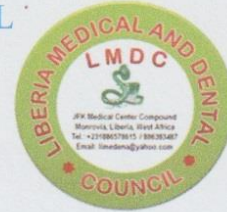

### **PUBLIC SERVICE ANNOUNCEMENT**

**TO: All Health Facilities (Hospitals, Health Centers, Clinics) & Health Stakeholders**

**SUB: PRE-REGISTRATION ASSESSMENT OF ALL HEALTH FACILITIES PRIOR TO CERTIFICATION FOR OPERATION 2025.**

**DATE: October 16, 2024**

By the Mandate of the Act establishing the Liberia Medical and Dental Council (LMDC) and in line with best international practices, promoted by the World Health Organization, the Association of Medical Councils of Africa (AMCOA), the International Association of Medical Regulatory Authorities (IAMRA), and the West Africa Health Organization (WAHO), the LMDC will begin the Pre-Registration Assessment of All Health Facilities (Public, Private, Faith-Based and Concession) for Operational Certification for 2025 starting from November 1, 2024 and will continue to March 31, 2025 when the registration and certification process will be officially closed.

The period for *“business as usual”* is OVER. We are encouraging all our valued Stakeholders to ensure that there is 100% compliance with the process. NO Health Facilities will be allowed to operate without certification after the 31<sup>st</sup> of March 2025. The Health and Sanitation component of the ARREST Agenda standards will be upheld.

Pre-Assessment fees are: **\$25usd** or its equivalent in Liberian Dollars for Montserrado county and **\$50usd** or its equivalent for health facilities outside of Montserrado County. Fees are payable in the following accounts or at the LMDC office.
